#### 4. New Business

(a) Approval of Minutes of February 28, 2013, Meeting

The Minutes were presented. A brief discussion was held to correct a typographical error. A motion was made by John Gardner and seconded by Molly Spearman to approve the minutes as corrected. The motion passed unanimously.

## (b) Approval of Fall 2013 GO Program

A Resolution was presented. Brian Nurick provided the Board with information on the Fall 2013 SCAGO GO Program including that the total par amount of taxable bonds would be approximately \$29,000,000 and the total par amount of the tax-exempt bond would be approximately \$113,000,000. After brief discussion, a motion was made by Tom Ashley and second by Rose Wilder that the resolution be adopted as presented. The motion passed unanimously.

#### (d) 2013 SCASBO Sponsorship

A letter was provided to the Board from SCASBO dated August 1, 2013, requesting a contribution of \$24,500 and a one-time contribution of \$15,000 to assist with sending SCASBO Board members to the SASBO conference in April 2014. After discussion, a motion was made by John Gardner and seconded by Rose Wilder to approve the first contribution as requested. The motion passed unanimously. A motion was made by Donnie Wilson and seconded by Molly Spearman to approved the \$15,000 contribution as requested. The motion passed unanimously.

## (e) 2013 SCASA Sponsorship

A letter was provided to the Board from SCASA dated June 30, 2013, requesting a contribution of \$25,000 to support SCASA programming during the 2013-14 year. After discussion, a motion was made by John Gardner and seconded by Tom Ashley to approve the contribution as requested. The motion passed unanimously.

# (f) 2013 Institute Sponsorship

A discussion was had about SCAGO's annual sponsorship of the South Carolina Financial Strategies and Concepts Institute. The Board members held a discussion on the amount of its 2013 sponsorship and it was decided that it would be \$7,500. A motion was made by Tom Ashley and seconded by John Gardner to approve a \$7,500 sponsorship as discussed. The motion passed unanimously.

## (g) 2013 Institute Registrations for Board Members

A discussion was had about SCAGO's continuing its past practice of paying the registration fee for those Board members who wished to attend the 2013 Institute. A motion was made by Donnie Wilson and second by John Gardner to continue that practice. The motion passed unanimously.
